READ THESE NOTES CAREFULLY. Dates are Tentative.* This list which is subject to change, includes meets we wish to attend. A revised meet schedule will be posted after responses from host clubs and judges are received. The Flip Flop meet and Carousel meet are not confirmed. Registration and payment for the CandyLand Classic and Shamrock Showdown (available to Diamond level and up), are due no later than October 14th (not subject to change). Where there are multiple days listed for an event, all days should be kept open until after registration deadlines. Gymnasts will be assigned to one of the days listed based on numbers of registrations received. It is a good idea to book accommodations for multiple nights. Make sure you book hotels in a way that will allow you to cancel part or all of the reservation without penalties once the sessions are announced by the host club.

The estimated cost for away meets includes projected amounts to cover operating costs generated as a result our team attending the meet. The operating costs must be equally shared by all team members attending meets regardless of level. If operating expenses are not completely covered by the meet fee, the shortfall must be equally divided by all team members attending the event. The more team members who attend an event, the lower the operating cost per gymnast will be. Team operating expenses for the World Championships will be equally shared by all team members who attend the meet regardless of level. Worlds will include Diamond level gymnasts and up. USAIGC does not authorize gymnasts to independently enter any meet. Parry's team members may only enter competitions under the auspices of the USAIGC Member Club which they are registered with, which is Parry's Gymnastics.

One coach will attend each session. Coaches are not expected to be present for award presentations for any session. Coaches enjoy attending awards ceremonies and may do so if practical.

Meet information flyers will be sent to you for each meet. Your expedient response to meet registration flyers is important. Gymnasts who are not registered by the deadlines will not appear on the team roster for the meet when submitted to the host club.

We are taking USAIGC annual registration renewals now. Mail a separate check for \$55 payable to USAIGC to Parry's Gymnastics, 1694 Private Drive, Hamilton, NY 13346. The check must indicate child's name and D.O.B. Parents are no longer permitted to register on the USAIGC website. Do not include the \$55 USAIGC fee with tuition payment or with your annual registration fee which is also \$55 and payable to Parrys Gymnastics. There are two \$55 registrations due. One, a separate check payable to USAIGC. The second \$55 check which is due on August 20th must be made payable to Parrys Gymnastics with your September tuition.
